

Safeguarding our School

Reminder of the School's Medication Policy

We would like to remind Parents and Carers that school staff will only administer medicines prescribed by a doctor and clearly labelled with the child's name, date and dosage.

Medicines must always be provided in the original container **as originally dispensed** by the pharmacist. This should be clearly marked with the child's name, date of dispensing and name of medication, and include the prescriber's instructions for administration.

No medication can be given to a pupil without written consent obtained from the person with parental responsibility for the child. Written consent is to be obtained and may take the form of a:

> Parental Consent Form; or; Included as part of a Care Plan regime.

Parents are welcome to come into school to administer over the counter medicines bought from a chemist when children need this during the day.
